## 3. Scope Of Works/Technical Specifications

## 3.1 BACKGROUND

The South African government has realised that a low carbon economy can bring benefits and particularly support climate change mitigation measures. The South African Government has already committed to reducing carbon emissions in line with specified targets for South Africa. As at 22 September 2021, the country's Nationally Determined Contribution (NDC) target range for 2025, has been updated from its original value of 398-614 Mt CO2-eq, to a range of 398-510 Mt for 2025. Of greater significance is our 2030 mitigation target range which has been updated from 398-614 Mt CO2-eq to a range of 350-420 Mt CO2-eq. In order to meet these emissions reduction targets, several strategies will need to be used towards meeting this goal. A strategy that should be considered is the potential for a good business cleaner fossil fuel technologies implementing.

Reporting to the Department of Mineral Resources and Energy, the mandate of the South African National Energy Development Institute (SANEDI) is to serve as a catalyst for sustainable energy innovation, transformation and technology diffusion in support of South Africa's sustainable development. Within SANEDI there is the Cleaner Fuels and Related Technologies (CFRT), a subprogramme under the Applied Energy Research, Development and Innovation programme. Using fossil fuels as an energy source while reducing GHG emissions is the idea behind cleaner fuels and related technologies. SA wants to use this idea in its quest to reach its Nationally Determined Contributions (NDC) targets because to its strong reliance on fossil fuels for its energy supply.

The CFRT embarked on a Cleaner Fuels Roadmap for South Africa project, and the project is broken into three phases, of which two phases have been concluded. The outcomes of first two phases included: Phase I that evaluated the supply and demand for energy in the coal, oil, and gas value chains, identified workable solutions to control GHG emissions, and suggested alternative feedstock possibilities; and, Phase II which narrowed down the range of technologies (based on certain techno-economic criteria) and provided a more thorough analysis and feasibility study of the technological possibilities. The technology's compatibility with the nation's climate change and Just Energy Transition standards was also investigated. We have now embarked on the third and final phase of the project.



South Africa's energy and climate change challenges are exacerbated by a reliance on Fossil Fuels for most of its primary energy supply. Approximately 90% of primary energy is derived from Fossil Fuels of which ~72% is coal. Moreover, coal provides ~85% of electricity generation capacity and ~92% of electricity production. Coal and gas are also used for the production of liquid fuels amounting to approximately 30% of the liquid fuels used in South Africa. This reliance on Fossil Fuels has led to ~440Mt CO2 emissions per year.

South Africa's coal industry contributes significantly to employment opportunities, income generation as well as accounting for 6% of the country's total merchandised exports. South Africa also has a significant requirement for additional energy supply of electricity generation capacity as well as liquid fuel production. Furthermore, there are a multitude of other industries that contribute to national CO2 emissions.

Notwithstanding South Africa's continually increasing implementation of clean energies and energy efficiency measures, Fossil Fuels are forecast to remain the major source of primary energy over the medium term.

SANEDI is well placed both nationally and internationally to pave the way towards a Cleaner Fossil Fuel future and has the support of global bodies in doing so. For example, SANEDI is already a partner in a number of the International Energy Agency's (IEA) specialised implementing agreements that inter alia share information and learning at a global level.

Phase III of the road map will aim to address the implementation plan based on the outcomes of the first two phases (Published in April 2022 and 2023 respectively). The implementation plan will focus on the targeted technologies and determine how these technologies could be rolled out in South Africa. The implementation plan will include skills requirements, legislation and soft/hardware required in order to adopt these technologies and their associated benefits for South Africa.



## 3.2 Project Objectives

The aim of this project is to:

a) Build on the outcomes of the first two phases, by focusing on the identified technologies. Provide a comprehensive implementation plan for each feasible technology, conduct a skills requirement assessment, identify relevant legislation and soft/hardware required to enable implementation. b) Identify availability of the above requirements in South Africa, gaps to be filled, and where and how to acquire that which is missing as well as the short-, mid- and long-term expectation of each requirement

## 3.3 Scope of Works

The scope of work for this project will seek to generate a concise, reader friendly document that utilizes the first two phases to inform the following requirements:

## 3.3.1 Produce a skills assessment plan

- Skills required for each technology (professional, skilled and semi-skilled)
- Overarching and transferable skills that can be used across some technologies
- Duration to acquire skills
- Cost to acquire skills
- Availability of skill in South Africa
- Gaps in skill availability
- Overall team qualifications for each technology
- Consider the JET implications (benefits and any disadvantages)

## 3.3.2 Soft/Hardware assessment plan

- Software required
- Hardware required
- Availability in South Africa
- Costs of acquiring
- Duration of training required to operate

## **3.3.3 Legislation requirements**

- Applicable South African legislation (including that of construction where necessary)
- Applicable Standards/Methodologies
- Availability of relevant legislation
- Permitting and Licencing requirements
- Opportunities to inform policy/legislation

## 3.3.4 Based on the above short-medium-long term recommendations this report should:

- Showcase success factors, hurdles/challenges, economics successful implementation of each recommendation
- Outline a feasible implementation plan with a clear summarised infographic plan included

## GOVERNANCE

Overall project governance will be managed by the SANEDI. The project shall be guided and reviewed by a Project Steering Committee, composed of members including:

- A representative from the Applied Energy Research, Development and Innovation programme of SANEDI and/or alternate
- Up to 3 representatives from the SANEDI identified stakeholder pool
- Other persons may be invited by SANEDI as and when deemed appropriate
- SANEDI shall chair the progress meetings
- The consultant will be expected to produce minutes and action items from all meetings within 1 calendar week of the meeting
- At least 3 meetings are deemed necessary, but more may be included, an inception meeting, a progress meeting and a final closure meeting after completed report submission, attended by the Project Steering Committee and any other person deemed relevant by SANEDI.

The acceptance of the Final Report shall be in accordance with the following procedures:

- Review by SANEDI
- External review if deemed appropriate by SANEDI
- Amendments being effected as recommended during the evaluation
- Consideration and recommendation by the PSC



## 3.4 Project duration

SANEDI requires a completed roadmap document by **28 February 2024**. This will be governed under the above administration and should include a payment schedule on deliverables of no less than 2 payments. Any deviations from this will need to be motivated in writing and approved by SANEDI. The project plan shall include a table outlining timeframes, enabling deliverables and costs as well as a schedule of each person's time and task allocation. Final payment will take place after approval of the final report.

## 4. Preference Points

## 1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender: - the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and - the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

1.2 Preference Points applicable:

a) The applicable preference point system for this tender is the **80/20** preference point system.

1.3 Points for this tender shall be awarded for:

- (a) Price; and
- (b) Specific Goals.

1.4 The maximum points for this tender are allocated as follows:

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 SANEDI reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the SANEDI.



## 2. DEFINITIONS

- (a) "tender" means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) "price" means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) "rand value" means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) "the Act" means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
- (f) "B-BBEE" means broad-based black economic empowerment as defined in section 1 of the Broad-Based Black Economic Empowerment Act;
- (g) "B-BBEE status level of contributor" means the B-BBEE status of an entity in terms of a code of good practice on black economic empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- (h) "bid" means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of goods or services, through price quotations, advertised competitive bidding processes or proposals;
- (i) "Broad-Based Black Economic Empowerment Act" means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (j) "EME" means an Exempted Micro Enterprise in terms of a code of good practice on black economic empowerment issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act;
- (k) "functionality" means the ability of a tenderer to provide goods or services in accordance with specifications as set out in the tender documents.
- (I) "proof of B-BBEE status level of contributor" means:
  - B-BBEE Status level certificate issued by an authorized body or person;
  - A sworn affidavit as prescribed by the B-BBEE Codes of Good Practice;
  - Any other requirement prescribed in terms of the B-BBEE Act;
  - "QSE" means a qualifying small business enterprise in terms of a code of good practice on black economic empowerment issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act;



## 3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

## **3.1. POINTS AWARDED FOR PRICE**

3.1.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS A maximum of 80 or 90 points is allocated for price on the following basis:

## 4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

(a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or

(b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system, then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.

**5.2 Phase 2: Mandatory Requirements:** It must be noted that bidders who fail to meet any of the *MANDATORY REQUIREMENTS* will be disqualified and not be evaluated further.

**5.3 Technical evaluation:** Bidders will be evaluated according to the below technical evaluation criteria.

Minimum Technical Threshold is 80%.

It must be noted that if the Bidder does not meet the 80% minimum threshold, the bidder will be disqualified and not be evaluated further.
