3. Scope Of Works/Technical Specifications

3.1 Project Background

The 12L Tax incentive programme encourages businesses to implement energy efficiency savings by allowing a tax deduction of 95c/kWh saved on energy consumption. The Incentive was promulgated on 1 November 2013 and is claimable until December 2025. It allows for all energy carriers, except renewable energy, which can be claimed under the 12B tax incentive.

Companies that want to claim a 12L allowance, have to measure their energy consumption in kWh equivalent over a period of 12 months. The results of this implementation/assessment period are then compared to 12 months of baseline measurement. Both the baseline measurement and savings are measured and verified by a measurement and verification (M&V) professional assigned by a SANAS-accredited M&V body.

SANEDI's role

According to the 12L Tax Incentives regulation, SANEDI is responsible to:

- Appoint suitably qualified persons to consider the reports submitted.
- Consider, keep and maintain all reports submitted by taxpayers claiming the allowance.
- Issue taxpayers with certificates containing the relevant information.
- Create and maintain a database of all issued certificates.
- Provide the Minister and the SARS Commissioner with access to the reports and to the 12L Tax Incentives database.

Before issuing an energy-savings certificate, SANEDI must be satisfied that the information contained in the application reports is accurate and:

- Complies with the South African National Standard "SANS50010:2018: Measurement and Verification of Energy Savings" as published by the South African Bureau of Standards (SAB) Standard Division;
- Is an accurate reflection of the energy-efficiency savings for which the taxpayer is claiming a
 deduction during the year of assessment; and
- Complies with the 12L Tax Incentive regulation.



12L Tax Incentive Participants

The regulation that introduced the 12L Tax Incentive falls under the National Treasury (NT) while the South African Revenue Service (SARS) implement the Tax Incentive claims from successful applicants. The 12L Tax Incentive Team at SANEDI interacts with the Department of Mineral Resources and Energy (DMRE) as the shareholder of SANEDI. SANAS accredited Measurement and Verification bodies are responsible for the independent technical assessment of energy efficiency savings. Other players include ESCOs and the expert panellists contracted by SANEDI to evaluate baseline and performance assessment reports. SANEDI plays an adjudication role in the whole process.

The purpose of this project is to procure a service provider to develop a Stakeholder Engagement Strategy, and an accompanying implementation plan for the period 2023 to 2025. The successful service provider will be expected to execute the Stakeholder Engagement Strategy and manage all stakeholder engagement related activities on behalf of SANEDI for a period of three years. All activities to be documented and a transfer of knowledge and skills to SANEDI's 12L Team is required by SANEDI. The contract for this work is expected to run for three (3) years and should include a suitable monitoring and evaluation process that is clearly defined and auditable.

3.2 Project Objectives

The objective of this project is to develop a 12L Tax Incentives Stakeholder Engagement Strategy and Implementation Plan.



4. Scope of Works

The project must consider the following and related matters.

4.1 Work package 1: 12L Tax Incentives Stakeholder Mapping.

- Identify all stakeholders, internal and external, in the 12L Tax Incentive space and classify them according to their influence and importance to the process.
- Stakeholder analysis to establish the needs and the impact of each stakeholder.
- Assess the interests of the different stakeholders and determine how these interests can be accommodated.

4.2 Work package 2: 12L Tax Incentives Stakeholder Strategy

- Identify the needs of each stakeholder by meeting them and documenting their expectations.
- Create a communications plan that will detail how each stakeholder will be consulted.
- Detail how the communications plan will be implemented and how it will be monitored. What will be a successful communications plan?
- Plan and host a minimum of four 12L stakeholder workshops per annum with all relevant stakeholders
- Any other issues deemed necessary to include by the successful service provider.

4.3 Work package 3: 12L Tax Incentives Stakeholder Engagement Implementation plan

- Detailed stakeholder engagement approach to ensure delivery of information to the right people.
- Detailed stakeholder engagement risks and mitigation options.
- Detailed implementation plan with all resources identified and costing of all resources.

4.4 Work package 4: Project Management

The project shall be managed through a Project Steering Committee (PSC) composed of members including:

- A representative of SANEDI/Energy Efficiency Programme;
- Up to three representatives from the SANEDI identified stakeholder pool;
- Other persons may be invited by SANEDI as and when deemed appropriate; and
- SANEDI shall chair the progress meetings.



The Steering Committee shall meet as follows:

- Inception Meeting to initiate the Project and agree on specific details;
- Thereafter, progress meetings on a monthly basis.
- A final closure meeting after completed final report submission.

4.5 Work package 5: Project Administration

The service provider will be expected to:

- Record written minutes of each Project Steering Committee
- Circulation of the minutes within five working days of the meeting
- Progress reports to be addressed at progress meetings
- Progress reports submitted at least three days before a progress meeting

4.6 Expected Deliverables

- Monthly minuted progress meetings with the project steering committee (PSC)
- Draft reports on each work package (WP) during progression, for inputs from the PSC and other stakeholders deemed relevant/necessary by SANEDI
- Final report containing the complete study (all WPs)
- Five hard copies (laid out, bound and printed)
- Two electronic copies (editable Word version and PDF print layout)
- Presentations to SANEDI and DMRE and others as required

5. Preference Points

PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2022

1. GENERAL CONDITIONS

- 1.1 The following preference point systems are applicable to invitations to tender: the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).
- 1.2 Preference Points applicable:
- a) The applicable preference point system for this tender is the 80/20 preference point system.
- 1.3 Points for this tender shall be awarded for:
 - (a) Price; and
 - (b) Specific Goals.
- 1.4 The maximum points for this tender are allocated as follows:

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 SANEDI reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the SANEDI.

2. **DEFINITIONS**

- (a) "tender" means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) "price" means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) "rand value" means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) "the Act" means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
- (f) "B-BBEE" means broad-based black economic empowerment as defined in section 1 of the Broad-Based Black Economic Empowerment Act;
- (g) "B-BBEE status level of contributor" means the B-BBEE status of an entity in terms of a code of good practice on black economic empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- (h) "bid" means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of goods or services, through price quotations, advertised competitive bidding processes or proposals;
- (i) "Broad-Based Black Economic Empowerment Act" means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (j) "EME" means an Exempted Micro Enterprise in terms of a code of good practice on black economic empowerment issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act;



- (k) "functionality" means the ability of a tenderer to provide goods or services in accordance with specifications as set out in the tender documents.
- (I) "proof of B-BBEE status level of contributor" means:
 - B-BBEE Status level certificate issued by an authorized body or person;
 - A sworn affidavit as prescribed by the B-BBEE Codes of Good Practice;
 - Any other requirement prescribed in terms of the B-BBEE Act;
 - "QSE" means a qualifying small business enterprise in terms of a code of good practice
 on black economic empowerment issued in terms of section 9 (1) of the Broad-Based
 Black Economic Empowerment Act;

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

3.1.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS A maximum of 80 or 90 points is allocated for price on the following basis:

Where

Ps = Points scored for price of tender under consideration

Pt = Price of tender under consideration

Pmin = Price of lowest acceptable tender

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:



- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
 - (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system, then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.
