Work specification (and Technical specifications)	<p>Introduction</p> <p>SANEDI is seeking to appoint a suitable, experienced and qualified contractor to undertake decommission and disposal batteries and PV support structure at Lucingweni Mini Hybrid Project site in the Eastern Cape. In particular the contractor shall:</p> <ol style="list-style-type: none"> 1. Decommission and dispose all Raylite batteries (220 Units with 440 cells) on site, which shall also include stripping and disposal of all reticulation cables inside the building. 2. Decommission and dispose all PV support structure (metal and wooded) <p>Project Background</p> <ul style="list-style-type: none"> • The Lucingweni mini-grid Hybrid Renewable Energy facility was constructed and operationalised in the early 2002. The facility at full operational capacity comprised an array of approximately 500 Solar PV modules and 6 Wind turbines with an installed capacity of 100 kW. The facility supplied green electricity through a reticulation network to the village of Lucingweni in the Eastern Cape Province. • The existing building which is approximately 127 m2 in size was used to house Balance of Systems (BOS) equipment for the 100 kW Hybrid mini-grid system in the village. The building is partitioned in two rooms with one room used to house all the (Raylite batteries – 220 Units with 440 cells) batteries whilst the other room was used to house inverters and other electronic equipment such as computers. • The project has since reached it useful life and is in the process of being decommissioned, with the first phase resulting decommissioning and removal from site of all wind turbines, solar PV modules, inverters and other electronic equipment. • The second phase of the project entails decommissioning and disposal of all batteries and solar PV support structures on site.

Location

- The project site is located at Lucingweni Village adjacent to Huleka Location approximately 90 km outside Umtata, Eastern Cape. The area is under the Konjwayo Tribal Authority in Nyandeni District Municipality. The Project site is located approximately 45 km from R 61 road that leads to Port St Johns and the GPS coordinates are S 31°49'26.6" E 029°15'48.9"

Scope of work

The scope of services to be provided by the contractor from the agreed commencement date shall include the following tasks:

- Decommission and recycle of all batteries (Raylite batteries – 220 Units with 440 cells) in accordance with the applicable laws, standards or practices
- Decommission and recycle all PV support structure (metal and wooden structure) on site in accordance with the applicable laws, standards or practices
- Clear any vegetation on site

The rights and obligations of contractor

- Contractor shall have the right to receive from the recycling company the total amount tendered for recycled material.
- Contractor shall deduct from the amount tendered for recycle material (batteries included) the cost incurred his for labour, transportation and other costs related to decommissioning and recycling from the project site.
- Contractor shall credit or debit any balance between the tendered amount for recycled material and the cost associated with decommissioning and recycling

Time Frame

- The contractor is expected to complete all tasks within 2 weeks from commencement date
