Work specification (and Technical specifications)	<p>1. Project Background</p> <p>SANEDI Cool Surfaces Programme responds to South Africa’s need for energy passive, low cost, low maintenance cooling technology for buildings. Commercial and residential buildings contribute to a large part of final energy consumption, in addition to Greenhouse Gas Emissions (GHG). South Africa has high average temperatures and hot climatic conditions that require cooling and air conditioning hence, high energy consumption. Under these conditions, cool roofs improve the energy and environmental performance of buildings by minimising solar heat gains. The specialised paint coating reflects solar radiation and prevents heat absorption. Cool surfaces applied to roofs not only reduce the energy required to cool building interiors significantly but also decreases the electricity demand on our fragile grid when rolled out on a large-scale. The cool coating also offers some protection against fire by retarding flame spread.</p> <p>2. Project Objectives</p> <p>SANEDI aims to set up a satellite shop to establish sustainable distribution network in underprivileged communities to self- install cool coatings. The project promotes the distribution & uptake of Cool reflective Coatings: passive-energy heat reduction, to champion entrepreneurship in disadvantaged communities. Scope of Works	<p>4. Scope of Works</p> <p>The Scope of Works for the Masiphumelele Satellite Shop Cool Surfaces Project requires a vendor to provide the following:</p>

4.1. Painting Equipment Supply

- Vendor to supply 4 paint brushes, 4 roller brushes, 4 paint trays, 1 A-Frame aluminium step ladder, 50 litres turpentine.
- Vendor to deliver the equipment within 14 working days of the agreement being signed.

4.2. Cool reflective coating product supply (2 weeks)

- Vendor to deliver the cool surface paint and equipment within 14 working days of the agreement being signed.
- Vendor to provide the manufacturer’s written recommendations for optimal application of product.
- Vendor to use product from manufacturer with at least three (3) years of manufacturing experience in cool reflective coating/ water proofing products.
- Provide clear calculations of Bill of Quantities: Include costs of all equipment and coating.
- Product to be priced per m2 for primer and coating materials and coating materials to cover 600m2 of roofing.
- Vendors must submit copies of their cool reflective coating’s manufacturer’s verified laboratory certificates, or the manufacturers are members of the South African Cool Surfaces Association (SACSA).

Refurbished Repurposed Shipping Container

The project requires a refurbished repurposed shipping container to securely store goods, to be delivered and correctly positioned within Masiphumelele in Cape Town.

Specification of the Shipping Container

A repurposed metal shipping container shall be 6m² (six square metres) x 3m² (three square metres), with opening on one side with locking mechanism and in good condition. The Shipping container must be free of the following defects:

- No corrosion on container surface (inside and outside)
- Sturdy and fully functional locking mechanism.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 SANEDI reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the SANEDI.

2. DEFINITIONS

- (a) “tender” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) “price” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) “rand value” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) “tender for income-generating contracts” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) “the Act” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

4. POINTS AWARDED FOR SPECIFIC GOALS
